## Treasurer's Report

Current BVEOP budget balances include: \$25.21 in Savings; \$16,752.48 in Checking; Money Market \$10,000; CD \$13,868.86; and Sunshine Fund Savings \$6,159.83; Sunshine Fund Checking \$1,131.20

## Sunshine Funds-

*We will be voting on the use of our Sunshine Funds to support our BVEOP Clerical members that were impacted by the fire.*

After discussion, it was determined to have a pampering shower for the BVEOP members who were impacted by the Fourmile Canyon Fire - Janice Wheeler and Diana Breed - both from Louisville Elementary School. Proposed date for the

shower is November 15, 2010 at Nissi's (95<sup>th</sup> and Arapahoe) in Lafayette. More information will be shared as plans are finalized. Paula will work with Vivian Campbell to finalize details.

We would like to sell Rada knives to raise additional funds for our Sunshine Fund (deadline is 11/5/10). All district principal's assistants received flyers and additional information through the district mail. Please share with people in your building. Jane Keene and Paula Miller agreed to serve on this committee. It would be wonderful to have some additional committee members. Please let us know if you are interested.

Because Janice and Diana are not sure at this point what their exact needs are, it was determined to give a cash donation from the Sunshine Fund next spring.
