The District Accountability Committee, (DAC), is a legally constituted committee of representatives from the Boulder Valley School District (BVSD). DAC representation includes at least one taxpayer without children in school as well as a parent, teacher, or staff member from each school within the district. Members representing individual schools are nominated by their School Accountability Committees (SAC) and individuals not associated with a school may be nominated as an at-large member by a member of the Board of Education. All nominations are submitted to the Board of Education for approval.

DAC is charged with legal responsibilities related to the "adequacy and efficiency of the educational and accountability programs" in the district. DAC advises the Board and informs the public about the implementation and effectiveness of the district's accountability programs.
