4. I am college-ready, and not in need of developmental education coursework in accordance with the education career pathway in which I enroll.		
5. My Individual Career and Academic Plan (ICAP) indicates my intention to earn a college degree in Education. (Counselor verified)		
6. I have applied to, and been accepted into, a postsecondary program to continue on an approved educator pathway at either Front Range Community College (I also agree to the <a href="#">FRCC Student Payment Agreement</a> ), Metro State University-Denver, University Northern Colorado, CSU Pueblo.		
7. I am entering the TREP program in the year immediately following my 4th year of high school and I have completed all high school graduation requirements.		
8. Upon entry to the TREP program, I have not been designated a TREP program participant in any prior year (can only participate in TREP for 2 academic years).		
9. I have completed the FAFSA and understand that a Pell Grant may be a better choice financially. I can not receive Federal Financial Aid while in TREP.		
10. I have authorized College Opportunity Fund (COF) to be applied to my tuition. I understand that credits attempted will be deducted from my COF lifetime account.		
OPTIONAL: I have signed up with <a href="#">TEACH Colorado</a> for access to resources to get a head start on my teaching career. TEACH Colorado provides a variety of free resources to aspiring educators. Future teachers are encouraged to sign up for free.

1. My parent/guardian and I met with my high school counselor to discuss whether the TREP program is in the best interest of my educational career. My counselor has ensured that the TREP program is in my best interests both academically and financially. (Pell grant recipients <u>may</u> be better served to graduate and enroll in college without TREP)		
2. My counselor has explained to my family and I that the TREP program only covers tuition at the in-state community college rate and that payment of tuition charged above the community college rate and any other expenses such as books, supplies, and fees will be my responsibility unless BVSD has agreed to pay some or all of those additional expenses. <u>ALL</u> students who qualify for TREP will qualify for in-state residency status for their TREP 5th and 6th years.		
3. My parent/guardian and I understand that if I do not complete a course or do not receive a grade of "C" or better, the family will be required to reimburse BVSD for tuition and I will need to petition to stay in the program. My parent/guardian and I also understand that grades earned in the TREP program are permanent on the my college & high school transcripts and may impact future financial aid awards.		
4. I understand that I must maintain a college GPA of 2.0 while in TREP. I may remain in TREP while completing my Associate's Degree in an Education field, but may not participate in the program for more than two years.		
5. My parent/guardian and I understand that I will not receive a high school diploma until I exit or complete TREP. The graduation date on the diploma will align with the exit or completion date of TREP.		
6. I have met with a representative from the postsecondary institution that I wish to attend to verify minimum prerequisites have been satisfied for the courses in which I intend to register. A college representative will help me register for coursework.		
7. I have submitted a one-page essay that describes how the TREP program will contribute and help to make possible their career and college goals.		
8. I understand that prior to each semester I participate in the TREP program, I will complete the College Before Graduation Request form for the upcoming semester. On this form, I will include updated contact information as well as list the courses I intend to take.		
9. I understand that in compliance with the Family Educational Rights and Privacy Act (FERPA) of 1974 and the Colorado's Student Data Transparency and Security Act, I give Boulder Valley School District and the college I intend to attend permission to exchange any of my academic records and student/personal information pertinent to my participation in the TREP Program, including but not limited to records, information of absences and disciplinary issues, grades, transcripts, in progress grades, class schedules, and billing information.		
10. I authorize Boulder Valley School District to release my SASID # to the college for the purpose of College Opportunity Fund (COF).		
11. With regard to college activities, I may participate in activities that I am qualified for but I am not eligible for NCAA athletic activities.		
12. I understand that I may only enroll in Guaranteed Transfer courses and/or courses which apply to the educator pathway.		
13. I understand that if I add, drop or withdraw from a college course, I will meet with the High School counselor and notify the District and that I am responsible for officially dropping the course through the college. I understand that if I withdraw from a course after the college's drop deadline, the school will record a "W" or "F" on my college transcript and I will be required to repay BVSD for tuition paid by the school district.		

In signing this agreement, I authorize the college to release my transcript to my school district at the end of each course and agree to all information stated above.
